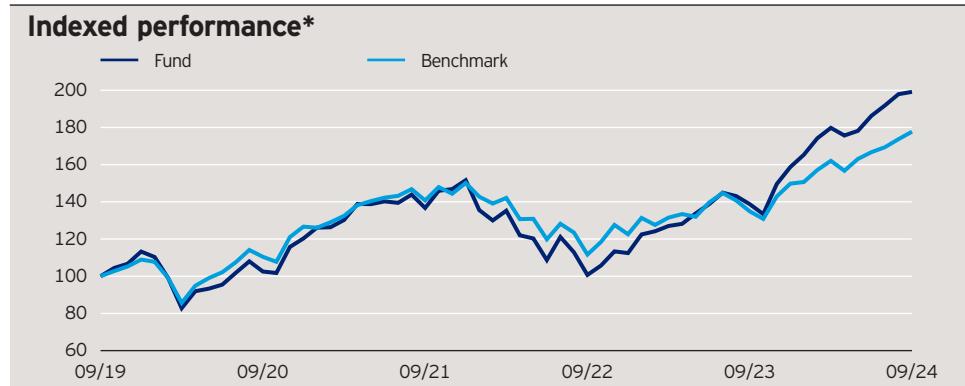
Investment risks

We seek what we believe to be the best investment ideas from across the world, building a portfolio of high conviction stocks that we think has the potential to deliver attractive returns over the long term.

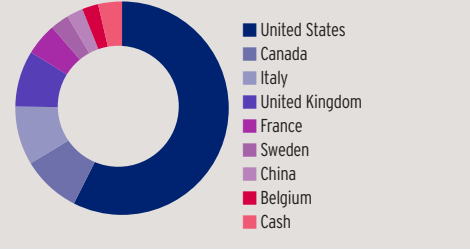

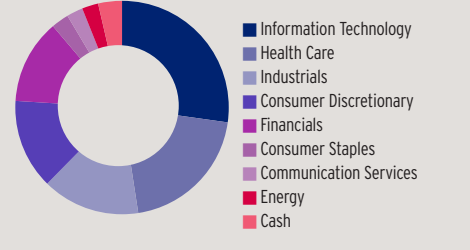
